



## INFORMATION NOTICE FOR EVENTS, GAMES AND COMPETITIONS

The purpose of this information notice is to inform the participants (the "Participants") in a transparent manner about the processes that may be implemented with respect to participants at events, games or competitions organised by Banque Raiffeisen (hereinafter referred to as the "Bank").

### **1. Controller**

The Participants personal data is processed by the Bank. The Bank's principal office is at the following address:

### **2. Purposes and legal basis of the operations**

The Bank collects and processes the data that is necessary for carrying out its activities:

#### To carry out the participation requests

The Bank uses the Participants data to:

- organise events, games and competitions
- manage participations
- and allocate prizes.

#### For the purposes of legitimate interests pursued by the Bank

The Bank processes the Participants data to:

- give the Participants regular information on the products and services offered by the BANK or the RAIFFEISEN group
- compile statistics.

### **3. Categories of data processed and provenance**

In addition to the information or elements that Participants may communicate during their participation in the events, games or competitions that it organises, the Bank may collect various data concerning the Participants, among which:

- data to identify the Participants
- data to contact the Participants

- the identity and consent of the legal representative if the Participant is a minor
- photos and videos (winners, awards, etc.).

#### **4. Categories of recipients of processed data**

The Participants data is shared with some of the Bank's internal departments, in strict compliance with the tasks entrusted to them, to carry out the above-mentioned purposes. compliance with the tasks entrusted to them, to carry out the above-mentioned purposes.

The Bank may share the Participants data with third parties in the following cases:

- with companies that host or manage all or part of the event
- in competitions, with the bailiffs in charge of monitoring and managing the game.

#### **5. Retention period**

The Participants' data is kept for the duration necessary for the events, the games or the competitions and which cannot exceed three years from the end of the event, unless the Participant should exercise his right of opposition in accordance with the legislation.

#### **6. Rights of the people concerned**

Within the limits and conditions imposed by the law, the Participants have the following rights:

- **The right to information.** Whilst the Bank hopes that this notice answers the Participants' questions, they can contact the Bank's Data Protection Officer for any further information.
- **The right to access their data.** Participants can access their data by contacting the Bank's Data Protection Officer. However, as the Bank processes a large amount of data and, in accordance with the law, Participants may be required to specify, before any data is provided, what data or operations, games or competitions your request covers.
- **The right to rectify data** when it is erroneous or obsolete.
- **The right to withdraw consent** if the Participant has given his consent for the processing of personal data; it should be noted that such withdrawal has no retroactive effect and will not prevent the Bank from continuing lawful processing, including those required by law.
- **The right to lodge a complaint** with the National Commission for Data Protection (*Commission nationale pour la protection des données- CNPD, Service des plaintes, 1 avenue du Rock'n'Roll L-4361 Esch-sur-Alzette, www.cnpd.public.lu*) if the Participant believes that the processing of his data is not in accordance with the law.

In certain cases and according to the conditions set by law (in which case the Bank will check beforehand that these conditions are fulfilled), the Participant also has the following rights:

- **The right to request that his data is erased.**
- **The right to request the restriction of the processing** of his data.
- **The right to object to the processing** of his data for prospecting purposes or for any other legitimate reason (unless there is a legitimate and compelling reason for the Bank to continue processing).
- **The right to the portability** of the data provided to the Bank, as far as technically possible.
