

## INFORMATION NOTICE ON COOKIES

The purpose of this information notice is to inform you in a transparent manner about the cookies that are used when you browse our websites and use our mobile applications.

### 1. *What is a cookie?*

A cookie is a small text file that a website stores on your computer or mobile device when you visit that website.

Cookies are widely used to operate websites, improve the browsing experience and provide information to website owners.

### 2. *What cookies do we use?*

Our websites and mobile applications use the following cookies:

#### Operating cookies

These cookies are used for technical purposes. They are used to check your browser's technical settings and to save the preferences that you set when you first visited the website. They are designed to ensure that you have the best possible web experience.

These cookies are essential for the operation of our websites. They let you use its main features (e.g. access your R-Net account). Without these cookies, you will not be able to use our websites normally.

### Audience measurement cookies

We use cookies in this category to analyse how visitors browse our websites. This data helps us better understand the use of the website, especially the profile of visitors, how they arrived on the website (e.g. direct access or via a search engine), which pages they are looking for, how long they stay on the site, etc. We can thus optimise and improve the website and the services offered. These statistics are compiled using Google Analytics, a web analytics service provided by Google Inc. whose IP address anonymisation feature is enabled to keep users anonymous.

### **3. *How to manage your cookies***

Our websites do not place any cookies on your device until you have given your consent via our Cookie Manager.

When a user visits one of our websites for the first time, they are informed about the use of cookies by means of a specific banner. The user is then asked either to accept the placing of all cookies included on the website pages that they visit or to set personalised cookie preferences.

You can change your cookie preferences at any time via the "Manage my cookies" button.

You can also configure your browser to accept all cookies, to reject all cookies, to notify you when a cookie is issued, inform you about its duration and content and let you refuse to accept it on your device, and to delete cookies periodically. Please note, however, that if you disable all cookies, some features of our websites or online applications will no longer work properly.
