

**Art. 1 – Name and purpose of Raiffeisen Molconcours 2025**

Banque Raiffeisen S.C. (hereinafter the “**organiser**”), which has its registered office at 4, rue Léon Laval, L-3372 Leudelange, and is registered in the Luxembourg trade and companies register under number B-20128, is organising a free entry drawing contest called “**Raiffeisen Molconcours 2025**” as part of a “Molconcours” event **from 20<sup>th</sup> January to 14<sup>th</sup> June 2025**.

As part of **Raiffeisen Molconcours 2025**, the organiser is offering participants a chance to win several prizes.

The contest is only open to participants residing in Luxembourg.

**Art. 2 – Terms of participation (individual participants)**

Participation in **Raiffeisen Molconcours 2025** is open to all (hereinafter “**participants**”):

- Aged between 4 and 20 (at the time of participation);
- With the prior consent of their legal guardian(s) for minors;
- Regardless of whether they are a customer of the organiser;
- Enrolled in a Luxembourgish school.

Participants will be divided into the following categories:

- Cycle 1 (4/5 years old);
- Cycle 2 (6/8 years old);
- Cycle 3 (9/10 years old);
- Cycle 4 (11/12 years old);
- High school (13/20 years old).

Persons who do not meet the conditions mentioned above may not participate.

**Art. 3 – Principle of Raiffeisen Molconcours 2025****3.1 Practical organisation**

**Raiffeisen Molconcours 2025** is organised by level:

- A “preselection” level, where the drawings are judged by a jury panel composed of Raiffeisen advisors;
- A “national” level, where the drawings are judged by a panel of artists and teachers;
- An “international” level, where the drawings are judged by a panel of representatives of the six organising countries.

**3.2 – Retrieval of brochures and drawing paper**

Participants can retrieve the **Raiffeisen Molconcours 2025** brochure and A3 drawing paper:

- From their teacher;
- By email by sending a request to [molconcours@raiffeisen.lu](mailto:molconcours@raiffeisen.lu);
- Or by completing the online form.

**3.3 – Submission of drawings**

To participate in **Raiffeisen Molconcours 2025**, participants must comply with the following rules in order to submit their drawings:

- Drawings must be submitted before 21<sup>st</sup> April 2025 by post to the Communications department of Banque Raiffeisen S.C. at following address : 4, rue Léon Laval L-3372 Leudelange;
- They must be in A3 format;
- For a digital drawing, please provide a scanned version of the final drawing and the participation form, along with a screenshot illustrating an intermediate step of the creation process, and sent it to [molconcours@raiffeisen.lu](mailto:molconcours@raiffeisen.lu);
- All fields in the entry form must be completed clearly;
- The drawing must relate to the set theme: "Your digital world".

Participants who meet the above criteria will be automatically entered into **Raiffeisen Molconcours 2025**. Drawings that do not contain the following mandatory information: the last name, first name, date of birth and the last name, first name and signature of the parent or legal guardian shall be considered null and void.

#### **Art. 4 – Selection of the winners**

The drawings submitted to the organiser will be judged as follows:

- A **"pre-selection"** jury panel will select 2,500 winning drawings among all the submissions received.
- A **"national"** selection panel will nominate 50 winning drawings (10 winners per category, including one winner who takes first national place) from the 2,500 "pre-selection" winners.
- An **"international"** panel will review the drawings that won the first national place from cycles 2, 3, 4 and from the High School category. The Cycle 1 winner will not be submitted to the "international" panel.

The jury panels will be neutral and will judge the drawings based on the following criteria: overall impression, autonomy, originality, imagination and strength of expression. Their decisions shall be final. There may be no recourse to the courts. By submitting their drawings, the participants warrant that they have drawn them themselves (that they are their own work) and assign publication rights for the drawing to the organiser.

The **pre-selection** winners will be announced on 7 and 8 Mai 2025 at the organiser's registered office; the **national** winners will be announced on 22 May 2025 at the organiser's registered office; and the **international** winners will be announced from 26 to 28 June 2025 at the premises of Raiffeisen Bank, in Vienna.

#### **Art. 5 – Prizes**

##### **5.1 – Participation gift**

Each participant will receive an age-appropriate participation gift when they submit their drawing:

- Participants aged 4 to 12: a buff / neck gaiter;
- Participants aged 13 to 15: a water bottle.

##### **5.3 "Pre-selection" prizes**

For Cycles 1 to High School:

- a medal

## 5.4 “National” prizes

For **Cycles 1 to High school**:

- 1<sup>st</sup> place: A creative box containing drawing tools, as well as an exclusive goodie bag filled with unique products created and/or selected by Jacques Schneider, Ambassador of the Raiffeisen Molconcours 2025.
- Remaining 9 winners of each category: A creative box containing drawing tools, as well as an exclusive goodie bag filled with unique products created and/or selected by Jacques Schneider, Ambassador of the Raiffeisen Molconcours 2025.

For the **High school** category, the winner of the 1<sup>st</sup> place will be given a chance (with their legal guardian's consent) to attend the international final, which will take place from the 26<sup>th</sup> to 28<sup>th</sup> of June 2025 at the premises of Raiffeisen Bank, in Vienna.

## 5.5 “International” prizes

An honorary award will be given to all international winners.

## Art.6 – Contacting the participants and the winners

### 6.1 – preselection winners

Participants from cycles 1 to High School will receive a medal symbolizing that their drawing has been pre-selected by the 'Pre-selection' Jury. Their drawing and their prize (the medal) will be handed to them starting June 2 by their teacher at their school.

### 6.2 – national winners

National winners will receive a medal, a certificate, and a letter announcing that they have won a prize. They must register for the award ceremony via an online form on our website to collect their prize and drawing.

### 6.3 – international winners

International winners from cycles 2 to 4 will receive their prize by post. The international winner from the High School category will receive their prize at the international award ceremony. In case of absence, the organizer will contact the international winner to arrange the prize collection details.

No messages will be sent to participants who have not won a prize.

## Art. 7 – Processing of personal data

All personal data that is collected will be processed by Banque Raiffeisen S.C., 4 rue Léon Laval L-3372 Leudelange.

The organiser reserves the right to interrupt or terminate **Raiffeisen Molconcours 2025** where events beyond its control prevent the smooth running of the contest.

**Art. 9 – Complaints**

Any complaints in relation to this contest may be made until 30 June 2025 and must be sent by registered letter to the organiser's postal address. No other complaints will be accepted.

**Art. 10 – Acceptance of the rules**

Participation in **Raiffeisen Molconcours 2025** shall automatically imply acceptance of these rules.

**Art. 11 – Force majeure**

The organiser may not be held liable if, for reasons of force majeure or any other unforeseeable cause beyond its control, **Raiffeisen Molconcours 2025** were to be postponed, halted or cancelled altogether. In this case, an announcement would be posted on the website [www.raiffeisen.lu](http://www.raiffeisen.lu).

**Art. 12 – Amendments to the rules**

Any amendments published during **Raiffeisen Molconcours 2025** on the website [www.raiffeisen.lu](http://www.raiffeisen.lu) will be considered as annexes to these rules.

**Art. 13 – Legal proceedings**

The organiser reserves the right to take legal action against any person who has committed or attempted to commit fraud.

**Art. 14 – Applicable law and competent courts**

Relations between the banking institution and the participants shall be subject to Luxembourg law exclusively. The courts of the Grand Duchy of Luxembourg shall have sole jurisdiction in the event of a dispute.
