

"Molconcours 2024" rules

Art. 1 – Name and purpose of Molconcours 2024

Banque Raiffeisen S.C. (hereinafter the "**organiser**"), which has its registered office at 4, rue Léon Laval, L-3372 Leudelange, and is registered in the Luxembourg trade and companies register under number B-20128, is organising a free entry drawing contest called "**Molconcours 2024**" from 15 January to 15 June 2024. This contest will involve various categories of prizes, which will be awarded to local, national and international winners by local, national and international juries (as the case may be) as part of a "Molconcours" event. The organiser will hold a "Class Prize" draw, in which classes that have registered for Molconcours 2024 will be in with a chance to be one of 50 classes to win entry tickets to Kass-Haff farm.

As part of Molconcours 2024, the organiser is offering participants a chance to win several prizes.

The contest is only open to participants residing in Luxembourg.

Art. 2 – Terms of participation

Art. 2.1 – Terms of participation (individual participants)

Participation in Molconcours 2024 is open to all minors (hereinafter "participants"):

- Aged between 4 and 17 (at the time of participation);
- With the prior consent of their legal guardian(s);
- Regardless of whether they are a customer of the organiser;
- With a valid postal address.

Participants will be divided into the following categories:

- Cycle 1 (4/5 years old);
- Cycle 2 (6/8 years old);
- Cycle 3 (9/10 years old);
- Cycle 4 (11/12 years old);
- High school (13/17 years old).

Persons who do not meet the conditions mentioned above may not participate.

Art. 2.2 – Terms of participation (classes)

Teachers from national and international primary schools and national and international high schools can register their class for **Molconcours 2024** via an online form available at <u>www.molconcours.lu</u>, which will automatically enter their class into the "**Class Prize**" draw referred to above.

Art. 3 – Principle of Molconcours 2024

3.1 Practical organisation

Molconcours 2024 is organised by level:

- A "local" level, where the drawings are judged by a jury panel composed of Raiffeisen advisors;
- A "national" level, where the drawings are judged by a panel of artists and teachers;
- An "international" level, where the drawings are judged by a panel of representatives of the six organising countries.

Art. 3.2 - Retrieval of brochures and drawing paper

Participants can retrieve the **Molconcours 2024** brochure and A3 drawing paper from:

- Their teacher;
- Their local Raiffeisen branch;
- Or by email by sending a request to molconcours@raiffeisen.lu.

Art. 3.3 – Submission of drawings

To participate in **Molconcours 2024**, participants must comply with the following rules in order to submit their drawings:

- Drawings must be submitted before 15 March 2024 at a Raiffeisen branch or sent by post to the Communications department of Banque Raiffeisen S.C.;
- They must be in A3 format;
- All fields in the entry form must be completed clearly;
- The drawing must relate to the set theme: "Giving Earth a Future".

Participants who meet the above criteria will be automatically entered into **Molconcours 2024**. Drawings that do not contain the following mandatory information: the last name, first name, date of birth and full postal address of the participant, and the last name, first name and signature of the parent or legal guardian shall be considered null and void.

Art. 4 – Selection of the winners

The drawings submitted to the organiser will be judged as follows:

- A "local" jury panel will select 3,105 winning drawings from among the submissions received.
- A "national" selection panel will nominate 15 winning drawings from among the 3,105 local winners.
- An "**international**" panel will review the drawings that won first prize submitted by participants from cycles 2, 3, 4 and by those in the High School category. Cycle 1 drawings will not be entered for review by the "international" panel

The jury panels will be neutral and will judge the drawings based on the following criteria: overall impression, autonomy, originality, imagination and strength of expression. Their decisions shall be final. There may be no recourse to the courts. By submitting their drawings, the participants warrant that they have drawn them themselves (that they are their own work) and assign publication rights for the drawing to the organiser.

The **local** winners will be announced on 18 and 19 April 2024 at the organiser's registered office; the **national** winners will be announced on 8 May 2024 at the organiser's registered office; and the **international** winners will be announced on 26 June 2024 at the premises of Caisse Fédérale de Crédit Mutuel (*société coopérative* - cooperative company) in Strasbourg.

Art. 5 – Prizes

5.1 Prizes for Cycle 1 participants

All Cycle 1 participants will receive a €25 Raiffeisen savings voucher that can be deposited in one of our Green Code KIDS or Green Code 12-18 savings products.

5.2 – Gadgets

Each participant will receive an age-appropriate gadget when they submit their drawing:

- Participants aged 4 to 12: a seed paper pouch;
- Participants aged 13 to 15: a cotton backpack;
- Participants aged 16 to 17: a cotton shopping bag.

5.3 "Local" prizes

For Cycles 1 to 4:

- 1st prize: a €100 Raiffeisen savings voucher and a €100 Cactus gift card;
- 2nd prize: a €75 Raiffeisen savings voucher and a €75 Cactus gift card;
- 3rd prize: a €50 Raiffeisen savings voucher and a €50 Cactus gift card;
- 4th prize: a €30 Raiffeisen savings voucher.

For the **High School** category:

- 1st prize: a €150 Raiffeisen savings voucher and a €150 Cactus gift card;
- 2nd prize: a €125 Raiffeisen savings voucher and a €125 Cactus gift card;
- 3rd prize: a €100 Raiffeisen savings voucher and a €100 Cactus gift card;
- 4th prize: a €50 Raiffeisen savings voucher.

5.4 "National" prizes

For Cycles 1 to 4:

- 1st prize: a €175 Raiffeisen savings voucher and a €175 Cactus gift card;
- 2nd prize: a €150 Raiffeisen savings voucher and a €150 Cactus gift card;
- 3rd prize: a €125 Raiffeisen savings voucher and a €125 Cactus gift card.

For the **High school** category, the winner of the 1st prize will be given a chance (with their legal guardian's consent) to attend the international final, which will take place on 26 June 2024 at the premises of Caisse Fédérale de Crédit Mutuel (*société coopérative* - cooperative company) in Strasbourg.

- 1st prize: invitation to the international final + a €250 Raiffeisen savings voucher and €250 in spending money OR a €250 Raiffeisen savings voucher and a €250 Cactus gift card;
- 2nd prize: a €175 Raiffeisen savings voucher and a €175 Cactus gift card;
 - 3rd prize: a €150 Raiffeisen savings voucher and a €150 Cactus gift card;

5.5 "International" prizes

An honorary award will be given to all international winners.

5.6 Class prize

Classes that take part in **Molconcours 2024** will be entered into the "**Class Prize**" draw. 50 classes will be drawn randomly to win entry tickets to Kass-Haff farm. The tickets will be valid for one year from the date on which the letter is sent to the teachers.

Art.6 - Contacting the participants and the winners

6.1 – Cycle 1

Cycle 1 participants will receive a €25 Raiffeisen savings voucher by post and Raiffeisen advisors will contact the legal guardians of the winners by phone.

6.2 - 4th prize winners

The winners of 4th prizes will receive a €30 (for Cycles 1 to 4) or a €50 (for the High School category) Raiffeisen savings voucher by post and Raiffeisen advisors will contact their legal guardians by phone.

6.3 – "Local" winners

"Local" winners (1st -3rd prizes) will receive a letter informing them that they have won a prize and inviting them to register via an online form available on our website in order to receive their prize and retrieve their drawing.

6.4 – "National" winners

"National" winners will receive a letter informing them that they have won a prize and inviting them to register via an online form available on our website in order to receive their prize and retrieve their drawing. The organiser will contact their legal guardian by phone.

6.5 – "International" winners

"International" winners will receive their prize at the international awards ceremony. If they cannot attend, the organiser will contact their legal guardian by phone to arrange a convenient date on which they can collect their prize.

No messages will be sent to participants who have not won a prize.

Art. 7 – Processing of personal data

All personal data that is collected will be processed by Banque Raiffeisen S.C., 4 rue Léon Laval L-3372 Leudelange.

Art. 8 – Liability

The organiser reserves the right to interrupt or terminate **Molconcours 2024** where events beyond its control prevent the smooth running of the contest.

Art. 9 – Complaints

Any complaints in relation to this contest may be made until 30 June 2024 and must be sent by registered letter to the organiser's postal address. No other complaints will be accepted.

Art. 10 – Acceptance of the rules

Participation in **Molconcours 2024** shall automatically imply acceptance of these rules.

Art. 11 - Force majeure

The organiser may not be held liable if, for reasons of force majeure or any other unforeseeable cause beyond its control, **Molconcours 2024** were to be postponed, halted or cancelled altogether. In this case, an announcement would be posted on the website <u>www.raiffeisen.lu</u>.

Art. 12 – Amendments to the rules

Any amendments published during **Molconcours 2024** on the website <u>www.raiffeisen.lu</u> will be considered as annexes to these rules.

Art. 13 – Legal proceedings

The organiser reserves the right to take legal action against any person who has committed or attempted to commit fraud.

Art. 14 - Applicable law and competent courts

Relations between the banking institution and the participants shall be subject to Luxembourg law exclusively. The courts of the Grand Duchy of Luxembourg shall have sole jurisdiction in the event of a dispute.
